The 42 hectares of land in Fung Yuen has been listed as a “Site of Special Scientific Interest” (SSSI) since 1980. There are over 200 species of butterflies in Fung Yuen, accounting for 80% of the Hong Kong total. Tai Po Environmental Association has been funded by the Environment and Conservation Fund to carry out "Management Agreement" project on the private land with high conservation value at Fung Yuen. The association is conducting ecological monitoring, habitat management, sustainable community development and education on site.
